1 Usage of the Guard App

The Corowell Guard App is used to verify and validate the electronic Passes that were issued by the Corowell App by reading the QR-Code of the electronic Pass.

5 General Functions

The Corowell Guard App is designed to support the user during all processes so that the user can successfully verify and validate electronic Passes that were issued by the Corowell App.

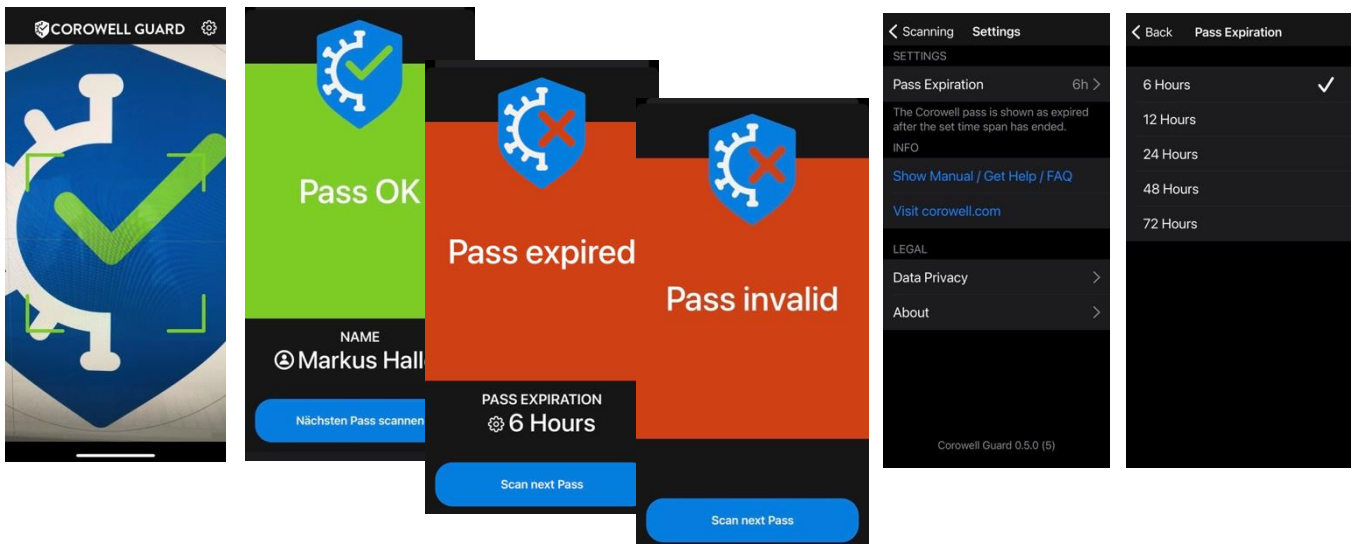


Figure 1 - Corowell Guard App Screens

The Corowell Guard App (iOS and Android) consists of the following screens. Figure 1 provides an overview of the Corowell Symptom Quick Test System Components

6 Use of the Corowell Guard App

The detailed use of the Corowell system is described in the following chapters.

6.1 Electronic Pass Scanning Screen

When the Corowell Guard App opens, the “access camera” shall be accepted by the user, so that camera is immediately active to scan Corowell Passes.

Once a Pass is scanned the App will check validity and authenticity of the Pass and provide one of 3 “result” screens (see below in Figure 2a “Pass OK”, 2b “Pass Expired” with indication validity period set and 2c “Pass Invalid” suggestion an invalid, copied or non-authentic Pass)

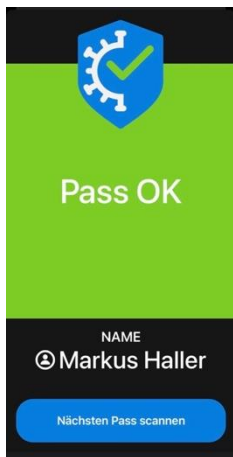

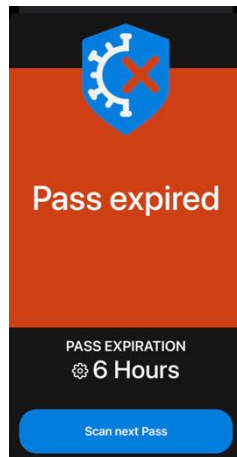

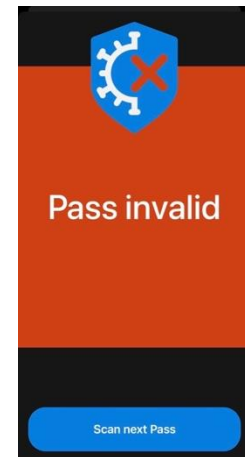

The language of the Corowell Guard App is automatically set to the language of the settings of the smartphone. If the smartphone setting has selected a language that is not available in the App then the default language is English.

You can also set the Pass Expiration duration, which you want to accept since a user has been issued his electronic Corowell Pass.

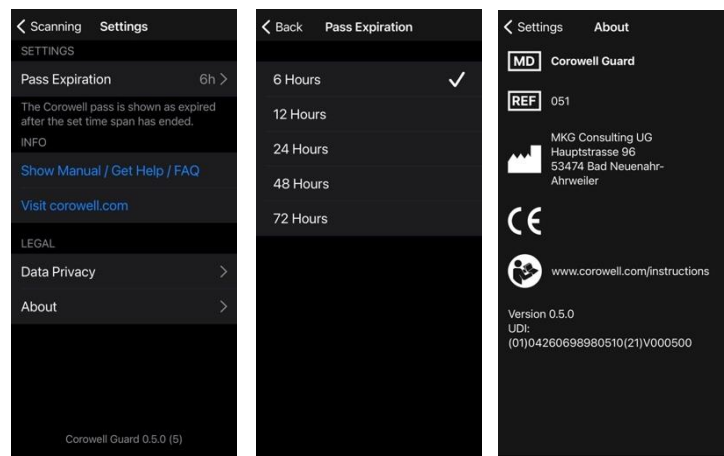












